DECLARATION OF RESTRICTIONS AND PROTECTIVE COVENANTS FOR

- 1. The Declaration of Restrictions and Protective Covenants for Tract 7, River Wilderness, Phase I (the "Subdivision") is recorded in Official Records Book 1164, commencing at Page 2830, of the Public Records of Manatee County, Florida (the "Declaration").
- 2. Pursuant to Paragraph 7.05 of the Declaration, at least two-thirds (2/3) of the property units in the Subdivision have approved the following Amendment to Article 6 of the Declaration by written consent pursuant to Section 617.0701, Florida Statutes (2012):

ARTICLE 6 RESTRICTIONS

6.01 - 6.05 Unchanged.

6.06 Leasing.

After approval by the ASSOCIATION, a dwelling unit may be rented leased provided the occupancy is only by the Lessee, and his the Lessee's immediate family, and permitted guests. No individual rooms may be rented, and no transient tenants may be accommodated. No lease shall be for a period of less than 30 days one (1) year. An OWNER may not lease his dwelling unit more than three times per year. As used in this Paragraph 6.06, the term "lease" shall mean the temporary right to exclusive possession of a dwelling unit for consideration, without regard to the nature, amount, adequacy, or form of consideration paid for possession of the dwelling unit.
